This agreement between the applicant and the OGA Golf Course Inc. constitutes an agreement between the two parties. The 2018 annual golf membership does not constitute equity in the OGA Golf Course. OGA Golf Course Inc. reserves the right to modify these rules, terms and conditions, or to terminate this agreement at any time without notification or explanation. The 2018 annual membership is non-transferrable and non-refundable. All members will use the facility at their own risk and must abide by club rules at all times.

The annual golf membership includes member charging privileges in both Orchards Grille and the Golf Shop with a \$500 credit limit. Annual members must pay for all charges within 30 days of the OGA Golf Course statement date. The undersigned hereby agrees to pay all costs of collections, including reasonable attorney fees, if this account is not paid within 90 days of the statement date. The undersigned further agrees to pay interest on the past due balance at the greater of one and one-half percent (1 ½%) per month. (Annual percentage rate of eighteen percent (18%), or the maximum permitted under applicable law.
